NOTIFICATION

Subject: - Amendments in Affiliation Bye-Laws- 2023 w.r.t. permit school to apply for affiliation with or without NOC.

As per the approval of the Managing Committee of the Bhartiya Shiksha Board meeting held on 01.03.2025 the following amendments has been made in Clause 2.3.5 of Affiliation Bye Laws 2023 which shall be applicable on applications of schools for affiliation under different categories for the session 2026-27.

Accordingly, following amendments in the Affiliation Bye Laws2023 are hereby notified: -

<p>Clause 2.3.5: -</p> <p>NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT</p> <p>*The Schools seeking affiliation with the Board shall submit formal "No Objection" to the effect that the State Government/ UT has no objection to the affiliation of the School with BHARTIYA SHIKSHA BOARD.</p> <p>*Provided that if there is inordinate delay without any justified reason in issuing the 'No Objection' for grant of affiliation to the concerned School with the Board, by any State/UT, the Board can start the process of granting Affiliation to such School after the expiry of 30 days from the date of receipt by the concerned authority of the State/UT, of the application along with all documents submitted by the School concerned, and the date of placing by the Board such application along with all documents as well as the proof of receipt of application of 'No Objection', by exercising the enabling provision provided in Clause 20(3) read with Clause 20(2) of the Model Bye-Laws for establishing the Bhartiya Shiksha Board.</p> <p>* Provided further that in cases of the schools seeking Affiliation with the Board from the</p>	<p>Clause 2.3.5: -</p> <p>NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT</p> <p>*The Schools seeking affiliation with the Board shall submit application with or without "No Objection" from the respective the State Government/UT.</p> <p>In case the School applies for Affiliation without NOC, the Board can proceed with the process of Affiliation exercising the enabling provisions provided in Clause 20(3) of the Model Bye-Laws for establishing the Bhartiya Shiksha Board; accordingly, on receipt of the Application from the respective Schools in the prescribed Form for the specific category, the Board shall send the application along with all documents by email to the designated Public Authority of the Department of the Education of the concerned State/UT. The Board shall also place such application along with all documents on its website for scrutiny of the Public. If any Public Authority including the Local Govt./State/Central Govt. does not convey its 'Objection or No Objection' within 30 days to the Board for grant of Affiliation to the concerned school, the Board can initiate the process for granting Affiliation, after expiry of 30 days from</p>

States/UTs, who have not formalized the system of issuing 'No Objection' and have not responded to the request of the Board in this regard sent in the months of August/September, 2022 even after several reminders, the Board can proceed with the process of Affiliation exercising the enabling provisions provided in Clause 20(3) of the Model Bye-Laws for establishing the Bhartiya Shiksha Board. The schools in such States/UTs, shall submit application in the prescribed Form to the Board and submit copy of the application along with all documents by email to the designated Public Authority of the Department of the Education of the concerned State/UT. The Board on receipt, shall place such application along with all documents on its website for scrutiny of the Public. If any Public Authority including the Local Govt./State/Central Govt. does not convey its 'Objection or No Objection' within 30 days to the Board for grant of Affiliation to the concerned school, after expiry of 30 days from the date of receipt of the application, the Board can start the process of granting Affiliation".

"Provided in case of schools of Switch over categories, applications shall be submitted by the School to the Bhartiya Shiksha Board furnishing declaration that there is no litigation or dispute pending before the erstwhile Board or the State/UT Govt. against it. The Board in turn shall intimate it to the designated Authority of the Dept. of Education of the concerned State/UT. All other provisions of the Affiliation Bye-Laws for the norms of affiliation shall be applicable to this category also." *The Schools seeking affiliation with the Board shall submit application with or without "No Objection" from the respective the State Government/UT.
