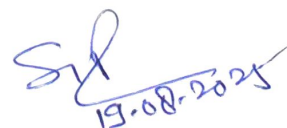
1. Schools will follow the spirit of NEP 2020 regarding the medium of instruction and assessment which clearly articulates freedom of children and their guardians for this above purpose.
